1.Application Scope

• Uxun automatically receives and records information from your computer and mobile device when you use Uxun, which is including but not limited to your IP address, type of browser, language used, date and time of access, software and hardware feature information, and web page records of your requirements; and in accordance with section 7 of this Policy, Uxun will collect such additional information as may be necessary to achieve the product functions listed therein.

2. Information Use
